1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

Description

Purpose-built second floor flat in a mid-terraced four storey and basement tenement building containing 11 flatted units at upper floor levels, and commercial premises at lower ground floor level.

Accommodation

Second Floor: Entrance Hallway, Lounge, Kitchen/Dining Room, Bedroom, Box Room, Bathroom.

Usual cupboard accommodation.

Gross internal floor area (m²)

73 m² or thereby.

Neighbourhood and location

The property forms part of an established residential area located to the west side of Edinburgh city centre. All normal facilities and amenities are readily available. The property is situated directly opposite Harrison Park West.

Age

The property is thought to be in the order of 125 years old.

Weather

Fair and drv.



Chimney stacks

Visually inspected with the aid of binoculars where appropriate.

The chimney stacks are of stone and rendered masonry construction. The chimneys incorporate metal flashings.

Roofing including roof space

Sloping roofs were visually inspected with the aid of binoculars where appropriate. Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The roof to the front of the building is of pitched timber construction clad externally in natural slate. The roof to the rear section of the building is of flat platform design and appears to be overlaid externally in bituminous felt.

We did not gain access to any roof void areas.

Rainwater fittings

Visually inspected with the aid of binoculars where appropriate.

The rainwater fittings are in cast iron, with guttering of half round and ogee profiles.

Main walls

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

The external walls to the building are of solid stone construction. The front elevation of the building has been finished with ashlar sandstone. The rear elevation of the building is finished with dressed and coursed sandstone.

Windows, external doors and joinery

Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open.

The windows to the flat under report have been fitted with replacement uPVC double glazed casement units. The external stairwell doors are in timber.

External decorations

Visually inspected.

The rainwater fittings are paint finished. The external stairwell doors are also paint finished.

Conservatories / porches

Not applicable.



Communal areas

Circulation areas visually inspected.

The access hallway and stair to the upper floors are communal. Entry to the building is controlled by means of a door entry telephone system.

Garages and permanent outbuildings

Not applicable.

Outside areas and boundaries

Visually inspected.

A communal roof terrace area is present to the rear of the building. The roof terrace has been formed over the rear element of commercial premises at lower ground floor level within the tenement. The roof terrace is bounded by metal rail fencing.

Ceilings

Visually inspected from floor level.

The ceilings within the flat are thought to be mainly in lath and plaster.

Internal walls

Visually inspected from floor level. Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

The internal walls and partitions within the flat are plaster finished.

Floors including sub floors

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

The flooring is of suspended timber construction. We did not access any sub floor voids.

Internal joinery and kitchen fittings

Built-in cupboards were looked into but no stored items were moved. Kitchen units were visually inspected excluding appliances.

The internal door facings and skirting boards are mostly in natural timber. Internal doors are mostly of traditional timber design.

The kitchen fittings include both wall and floor mounted units. Worktop and storage space is adequate.



Chimney breasts and fireplaces

Visually inspected. No testing of the flues or fittings was carried out.

The fireplace within the lounge has been fitted with a gas fire. Fireplaces elsewhere within the property have been removed.

Internal decorations

Visually inspected.

Internal decorations are mainly finished with paper and emulsion paint. Sections of walls and flooring are finished with decorative tiling.

Cellars

Not applicable.

Electricity

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains electricity is installed. The electricity meter and consumer unit are located at high-level within the entrance hallway.

Gas

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains gas is installed. The gas meter and isolator value are located at high-level within the entrance hallway.

Water, plumbing and bathroom fittings

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation. No tests whatsoever were carried out to the system or appliances.

Mains water is installed. Accessible pipework was found to be principally in copper and plastic. It should however be noted that in a property of this age the original plumbing installation would have been in lead. It is possible that sections of concealed lead pipework will be found to remain. The cold water storage tank is in plastic.

The sanitary fittings include a bath with WC and wash-hand basin. A separate thermostatic shower is also provided.



Heating and hot water

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Gas fired central heating is installed. The central heating system is served by a wall mounted condensing combination boiler located within the kitchen. The boiler serves panel radiators in all main rooms. The main heating system is supplemented by a gas fire that has been fitted to the fireplace within the lounge.

Hot water is generated on-demand by the primary heating system.

Drainage

Drainage covers etc were not lifted. Neither drains nor drainage systems were tested.

The property is understood to be connected to the public sewer.

Fire, smoke and burglar alarms

Visually inspected. No tests whatsoever were carried out to the system or appliances.

Fire detection and alarm equipment are present within the property. We recommend that it be verified that the provision meets with current fire safety standards.



Any additional limits to inspection:

Only the subject flat and internal communal areas giving access to the flat were inspected.

If the roof space or under-building / basement is communal, reasonable and safe access is not always possible. If no inspection was possible, this will be stated. If no inspection was possible, the surveyor will assume that there are no defects that will have a material effect on the valuation.

The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance.

We did not inspect the property for the purpose of identifying invasive plants. Invasive plant species are ones which typically cause ecological or economic harm in a new environment where they are not native. In some instances, invasive plants can also cause damage to built structures and may render property unsuitable for mortgage lending. While not an exhaustive list, invasive plant species include Japanese Knotweed, Giant Hogweed and Himalayan Balsam. Our valuation is made on the basis that invasive plant species are not present and note that identification is best carried out by a specialist contractor. Commonly invasive plant species require eradication by licensed contractors and the cost of eradication works may prove significant. Where we are made aware of invasive plant species being present at a property, we reserve the right to revise our assessment of Market Value.

The valuation assumes that no deleterious nor hazardous materials nor techniques have been used in the construction, and that the land is not contaminated.

A structural survey was not instructed and we have not inspected the woodwork or other parts of the property which are covered, unexposed or inaccessible and we are therefore unable to report that any such part of the property is free from defect.


It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No tests have been undertaken of any appliance or system. No access was available beneath sanitary or kitchen fittings.

At the time of survey the property was fully furnished, with fitted floor coverings in position. Detailed inspection of surface flooring was accordingly restricted. Inspection was further obstructed by the vendor's personal possessions and some stored items. We did not gain access to any roof voids. External inspection was made from ground level only. Large sections of the roof coverings and chimney stacks were not visible.

2. CONDITION

Notes:	Indications of structural movement were noted in the outer walls of the building. The movement is most prominent on the rear elevation where several window lintels have broken and steel retaining bars have been fitted. On the basis of a single inspection, the movement appears historic and is not thought to be a consequence of a serious or ongoing structural fault. Related repairs are not considered necessary at this time. We do however note that where structural movement has occurred, the masonry to outer walls may be subject to a requirement for regular and above average maintenance.

Notes:	No obvious significant dampness, timber decay or infestation was noted within the limitations of the inspection.

Notes:	The chimney stacks were not fully visible from ground level. Where visible the masonry surfaces, together with visible flashings and skews, were noted to be showing above average weathering, and related repairs will be necessary as items of ongoing maintenance.

Notes:	Our inspection of the roof coverings was restricted to the front roof slope only. We cannot comment with any meaningful authority on the overall condition of the roof coverings. We note that flat roof coverings are commonly found to have a limited life expectancy. Our valuation of the property is made on the basis that no significant roofing related expenditure will prove necessary in the short to medium term. It is considered prudent the advice of a competent roofing contractor be obtained in order to gauge current and future liabilities with increased accuracy. We did not gain access to any roof void areas and cannot comment on

Signs of weathering to the outer stone surfaces were also apparent and some sections of stonework are eroded and open jointed. Where structural movement has occurred, several window lintels have been broken and steel retaining bars have been fitted. Liability for communal maintenance and repairs to the outer masonry finishes should be anticipated.

Repair Categories

Remember

Warning

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. Guidance Notes on Accessibility Information

Three steps or fewer to a main entrance door of the property: In flatted developments the 'main entrance' would be the flat's own entrance door, not the external door to the communal stair. The 'three steps or fewer' are counted from external ground level to the flat's entrance door. Where a lift is present, the count is based on the number of steps climbed when using the lift.

<u>Unrestricted parking within 25 metres:</u> For this purpose, 'Unrestricted parking' includes parking available by means of a parking permit. Restricted parking includes: Parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coinoperated machines.

4. VALUATION AND CONVEYANCER ISSUES

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated re-instatement cost for insurance purposes.

Matters for a solicitor or licensed conveyancer

The tenure is understood to be outright ownership.

Usual Scottish legal enquiries should be made. If the legal advisers find there are significant variations from the standard assumptions then this should be referred back to the Surveyor.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

It should be confirmed that any liability for maintenance of the roof, general building fabric and common parts is shared upon an equitable basis that is not unduly onerous to the subject property. Furthermore it should be confirmed that there are no outstanding common repairs or bills for common repairs.

It is evident the property has been subject to some internal alteration. It appears that a wall has been removed to enlarge the box room. It also appears that a wall has been removed to enlarge the bathroom. The valuation is made on the basis that any required permissions and approvals have been obtained. This should be confirmed.

Estimated re-instatement cost for insurance purposes

We recommend that for reinstatement cost assessment purposes, the subjects be insured for a sum not less than £350,000 (THREE HUNDRED AND FIFTY THOUSAND POUNDS). This figure is an opinion of an appropriate sum for which the property and substantial outbuildings should be insured against total destruction. The figure assumes reconstruction of the property in its existing configuration and in the same materials. The figure bears no direct relationship to current market value. It is recommended that the level of cover is kept under regular review to ensure that you remain adequately insured. For properties with construction types not covered by BCIS, or where properties are Listed or situated within Conservation Areas, you should seek further specialist insurance advice.

Valuation and market comments

It is our opinion the current Market Value of the property on a basis of vacant possession and in current condition may be fairly stated at the sum of £300,000 (THREE HUNDRED THOUSAND POUNDS).

The Market Value expressed herein is effective as at the date of valuation. The Seller and Buyer are advised that Market Value may rise or fall as market conditions change. Should parties relying on this report and valuation consider market conditions to have changed materially from those prevalent at the date of this valuation, a revaluation should be instructed.

PART 1 – GENERAL

1.1 THE SURVEYORS

The seller has engaged the surveyors to provide the Single Survey Report and a generic Mortgage Valuation Report for lending purposes. The seller has also engaged the surveyors to provide an energy report in the format prescribed by the accredited energy assessment company.

The surveyors are authorised to provide a transcript or retype of the generic Mortgage Valuation Report on a lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the lender but will contain the same information, inspection date and valuation figure as the generic Mortgage Valuation Report and the Single Survey. The surveyors will decline any transcript request which requires the provision of information additional to the information in the Single Survey Report and the generic Mortgage Valuation Report until the seller has conditionally accepted an offer to purchase made in writing.

Once the seller has conditionally accepted an offer to purchase made in writing the purchaser's lender or conveyancer may request that the surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the surveyors, an additional fee may be incurred by the purchaser. Any additional fee will be agreed in writing.

If information is provided to the surveyors during the conveyancing process which materially affects the valuation stated in the Single Survey Report and generic Mortgage Valuation Report, the surveyors reserve the right to reconsider the valuation. - the purchaser; and
- the professional advisers of any of these.



The surveyors acknowledge that their duty of skill and care in relation to the report is owed to the seller and to the purchaser. The surveyors accept no responsibility or liability whatsoever in relation to the report to persons other than the seller and the purchaser. The seller and the purchaser should be aware that if a lender seeks to rely on this report they do so at their own risk. 1.4 GENERIC MORTGAGE VALUATION REPORT

1.8 CANCELLATION

The seller will be entitled to cancel the inspection by notifying the surveyor's office at any time before the day of the inspection.

The surveyor will be entitled not to proceed with the inspection (and will so report promptly to the seller) if after arriving at the property, the surveyor concludes that it is of a type of construction of which the surveyor has insufficient specialist knowledge to be able to provide the inspection satisfactorily. PART 2 - DESCRIPTION OF THE REPORT

2.1 THE SERVICE

The Single Survey is a report by an independent surveyor, prepared in an objective way regarding the condition and value of the property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an energy report as required by statute and this is in the format of the accredited energy company. In addition, the surveyor has agreed to supply a generic mortgage valuation report.

2.2 THE INSPECTION

The inspection is a general surface examination of those parts of the property which are accessible: in other words, visible and readily available for examination from ground and floorlevels, without risk of causing damage to the property or injury to the surveyor.

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The inspection is carried out with the seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.



The surveyor will not carry out an asbestos inspection and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats, it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan are in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 THE REPORT

The report will be prepared by the surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the property, will be concise and will be restricted to matters that could have a material effect upon value and will omit items that, in the surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the property is free of any other minor defects.

Throughout the report, the following repair categories will be used to give an overall opinion of the state of repair and condition of the property.

- 1. **Category 3:** Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the property or cause a safety hazard. Estimates for repairs or replacement are needed now.
- 2. Category 2: Repairs or replacement requiring future attention, but estimates are still advised.
- 3. **Category 1:** No immediate action or repair is needed.

WARNING: If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the property. This is particularly true during slow market conditions when the effect can be considerable.

Parts of the property, which cannot be seen or accessed, will not be reported upon and this will be stated. If the surveyor suspects that a defect may exist within an unexposed area and which could have a material effect upon the value, he may recommend further investigation by specialist contractors.

2.4 SERVICES

Surveyors are not equipped or qualified to test the services and therefore no comment can be interpreted as implying that the design, installation and function of the services are in accordance/compliance with regulations, safety and efficiency expectations. However, comment is made where there is cause to suspect significant defects or shortcomings with the installations. No tests are made of any services or appliances.



2.5 ACCESSIBILITY

A section is included to help identify the basic information interested parties need to know to decide whether to view a property.

2.6 ENERGY REPORT

A section is included that makes provision for an energy report, relative to the property. The surveyor will collect physical data from the property and provide such data in a format required by an accredited energy company.

The surveyor cannot of course accept liability for any advice given by the energy company.

2.7 VALUATION AND CONVEYANCER ISSUES

The last section of the report contains matters considered relevant to the conveyancer (solicitor). It also contains the surveyor's opinion both of the market value of the property and of the re-instatement cost, as defined below.

"Market Value" is the estimated amount for which a property should exchange on the date of valuation between a willing buyer and a willing seller in an arm's-length transaction after proper marketing wherein the parties had each acted knowledgeably, prudently and without compulsion. In arriving at the opinion of the Market Value the surveyor also makes various standard assumptions covering, for example, vacant possession; tenure and other legal considerations; contamination and hazardous materials; the condition of un-inspected parts; the right to use mains services; and the exclusion of curtains, carpets etc. from the valuation. In the case of flats, the following further assumptions are made that:

- *There are rights of access and exit over all communal roadways, corridors, stairways etc. and to use communal grounds, parking areas and other facilities;
- ➤ *There are no particularly troublesome or unusual legal restrictions;
- *There is no current dispute between the occupiers of the flats or any outstanding claims or losses; and the costs of repairs to the building are shared among the coproprietors on an equitable basis.

Any additional assumption, or any found not to apply, is reported.

"Re-instatement cost" is an estimate for insurance purposes of the current cost of rebuilding the property in its present form unless otherwise stated. This includes the cost of rebuilding the garage and permanent outbuildings, site clearance and professional fees, but excludes VAT (except on the fees).





The energy efficiency rating of your home
