(Aluminum Wiring) Previous owners checked box for aluminum wiring and stated "house was built in 1965 majority of house has new wiring. Separate power boxes".
 (Previous Foundation Repair) Previous owners stated "2003 when we bought the house several beams under house were replaced."
 (Previous Roof Repair) New roof installed on the main house in 2017, plus in 2023 a 12 year sealant added to both main and secondary house roofs.
 (Previous Other Repair) Previous owners stated "House is 1/2 cedar. We had planks and trim treated and sealed and painted 100%".
 (Unplatted Easements) There is an alleyway below the fenced pool and secondary house area. We do not use it but do clear the vegetation annually.
 (Wood Rot) One deck plank has a few inches of wood rot near the master bedroom.
 (Termites Treatment) Previous owners stated "2003 had an area that needed treatment when we purchased the house. We have had no problems since".
 We have had no issues since we purchased the home and have regular pest control service.
 (Termites Repaired) Previous owners stated "The master bathroom. The previous owners carried a policy with Orkin and they replaced all damaged areas, remodeling the specific area".
 (Termite WDI Repair) Previous owner stated "When we purchased the home in 2003 the previous owner policy with Orkin, the Orkin company came and in and treated, removed all the damaged area and rebuilt the area of the master bathroom. That happened in 2003 and we have kept a pest control company up-to-date."

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is considered to be a moderate risk of flooding.

"Flood pool" means the area adjacent to a reservoir that lies above the normal maximum operating level of the reservoir and that is subject to controlled inundation under the management of the United States Army Corps of Engineers.

"Flood insurance rate map" means the most recent flood hazard map published by the Federal Emergency Management Agency under the National Flood Insurance Act of 1968 (42 U.S.C. Section 4001 et seq.).
