1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Neighbourhood and location	The subjects are located on the west side of Gwydyr Road and extends down to Comrie Road. The property is located close to the entrance to Ardvreck Private School. The surrounding area is mainly residential in character. Day to day amenities are available locally with Crieff town

centre located less than 1 mile to the southeast.

Weather	It was dry at the time of inspection.
Chimney stacks	Visually inspected with the aid of binoculars where appropriate.
	Chimneys are of stone construction. Visible flashings are mainly metal.

Roofing including roof space

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The roof is timber pitched and overlaid in slates although incorporates a flat mid section. There are timber fronted dormer projections and these have vertically hung slates to the sides and set under flat roofs.

All areas of flat roof are understood to be finished with a PVC membrane although we were unable to inspect these from ground floor level.

Limited access was obtained to eaves areas via cupboards at the attic floor level. The inspection was also restricted by contents and insulation present. Only partial access was obtained to inspect the underside of the roof structure and in particular, no meaningful inspection of the underside of the flat roofed areas could be obtained internally. We were informed that insulation was added to the underside of the flat roofed area and no access was obtained to confirm this.

Rainwater fittings	Visually inspected with the aid of binoculars where appropriate. Gutters and downpipes are formed with a mixture of cast iron and PVC installations.
Main walls	Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected. The walls are predominantly traditional stone construction although there are areas of brick sections to the rear and these are rendered.
Windows, external doors and joinery	Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open. There is a traditional timber six panel front door with glazed surrounds/fanlight and a timber back door, also with a glazed fanlight. Windows mainly comprise timber sash and case single glazed installations although there is a double glazed unit to the rear of the kitchen. Windows at the attic floor level also comprise uPVC sealed unit double glazing of mixed age and type.
External decorations	Visually inspected.
Conservatories / porches	There is no conservatory/porch.
Communal areas	There are no communal areas pertaining to the property.

Garages and permanent outbuildings There is a detached single garage garage is mainly of rendered brid under a pitched roof overlaid with

There is a detached single garage accessed from Gwydyr Road. The garage is mainly of rendered brick construction (part timber) and set under a pitched roof overlaid with felt. There is an "up and over" vehicular access door to the front.

There is also a row of stone outbuildings which are partly open fronted and these provide additional storage. These have a metal clad roof.

There are also more minor non permanent outbuildings which do not form part of this report.

Outside areas and boundaries

Visually inspected.

Access is taken from a private entrance from Gwydyr Road and a surfaced drive leads down to a gravelled parking area. There is a metal gated access (which is slightly restricted) and boundaries are formed mainly with stone.

There is also a pedestrian gated access to Comrie Road.

Ceilings Visu

Visually inspected from floor level.

Consistent mainly with lath and plaster construction. Some areas have also been relined with plasterboard.

Internal walls

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Predominantly lath and plaster construction. Some sections in ancillary areas are also partly timber lined and part plasterboard.

Floors including sub floors

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

Flooring is mainly of suspended timber construction in ancillary areas at ground floor level and partially concrete such as the utility. Fitted floor coverings are present throughout the property restricting the inspection and no access was obtained to inspect any sub floor area.

Internal joinery and kitchen fittings

Built-in cupboards were looked into but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

There is a fitted kitchen comprising painted floor and wall mounted units. Internal doors are traditional style timber installations and there are timber and carpeted stairs between each level. The stair to the attic is narrower.

Chimney breasts and fireplaces

Visually inspected. No testing of the flues or fittings was carried out.

There are mainly open fires in the main reception rooms in addition to a wood burning stove in the smaller living room. There are also open fires in some of the bedrooms although these do not appear in current use.

Internal decorations

Visually inspected.

Cellars

There is no cellar pertaining to the property.

Electricity

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains electricity. The main consumer unit is located in a cupboard on the landing and this houses circuit breakers.

Gas

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains gas. The gas meter is located externally at the side of the property. There is a gas fired central heating system.

Water, plumbing, bathroom fittings

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Mains water. Visible plumbing is mainly copper and PVC. There is a two piece white suite in the ground floor WC and a four piece white suite in the main bathroom which includes a separate mixer shower enclosure. There is a three piece white suite in both en-suite shower rooms.

Heating and hot water

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

There is a gas fired central heating system served by an Ideal Mexico boiler located behind fitted units within the kitchen. Heat is distributed internally via radiators. The central heating also provides the hot water supply in conjunction with the hot water tank located in the bathroom cupboard. The tank is finished with a spray foam insulation. An electric immersion heater would seem to supplement the hot water supply.

There are also two solar panels located on the roof which also supplement the hot water supply.

Drainage

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Mains.

Fire, smoke and burglar alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

From February 2022, new smoke alarm standards are being introduced in Scotland and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.


Additional limits to inspection

The property was occupied at the time of inspection and there were contents, furniture and fitted floor coverings present throughout. No access was obtained to inspect any sub floor area and only limited access was obtained to eaves areas and this is further restricted by insulation and contents present. No access was obtained to inspect the underside of the main parts of the roof. Only a very limited inspection of the external fabric could be obtained from ground floor level partly due to the sloping nature of the site. In particular, no meaningful inspection of flat roofed areas could be obtained from ground floor level and only a restricted view of chimneys could be obtained.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

This may relate to intermittent water ingress around chimney flashings/adjoining junctions although we were unable to establish this as it was dry at the time of inspection. Sub floor ventilation is partially restricted by vegetation/ground levels and some staining was noted near rainwater fittings. Given the age and nature of the property in conjunction with the findings, it would be advisable to have the property inspected by a reputable firm specialising in the treatment of dampness and timber defects to ascertain the extent of repairs required and likely costs in this regard.

Notes		There is typical weathering/discolouration to stonework and flashings. There is typical staining around chimneys. As previously stated, this may relate to previous water ingress and it would be prudent to have chimneys checked and overhauled to ensure these are maintained in a watertight condition. From a restricted ground level inspection, chimneys are likely to require a normal programme of ongoing maintenance. It be prudent to have these checked/maintained in conjunction with regular roof maintenance.

Notes		It is understood that the flat roofed areas have been recovered with a PVC membrane. We were unable to verify this from the limitations of inspection. A number of slipped, damaged and missing slates were evident across roof slopes as well as stained/weathered metalwork. The roof is considered to be in a condition consistent with age and type and will require an ongoing programme of regular maintenance. As previously stated, there is typical salting and staining of timbers within the roof void, particularly at the rear chimney/adjoining areas.

Installations would benefit from a general overhaul and redecoration. It should be appreciated that it was dry at the time of inspection and as such we are unable to confirm if all areas are currently watertight.

Notes		Walls are generally well presented although there are weathered/delaminating sections to areas such as window/door openings. Cleaning and repointing/repair would form part of a normal maintenance programme. Some damaged render was also noted to parts of the rear wall fabric exposing some brickwork below.

Notes		The main windows have undergone a programme of refurbishment by Ventrolla and it is understood that works were carried out some 15 years ago. Draughtproofing was added at this stage. Windows are however of an age and type which will require ongoing repair and maintenance. Windows at the attic floor comprise uPVC sealed unit double glazed installations of mixed age. These are however consistent with being in excess of 20 years old and will require a programme of age related maintenance. There is some discolouration/clouding to double glazed units. There are also timbers around the roof edging and other areas of external joinery which will require a normal programme of decorative repair. Some sections may require to be cut out and replaced in conjunction with a programme of decoration.

4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a solicitor or licensed conveyancer

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include changes to the original maid's room. This involved removal of a stair. Works were carried out some 15 years ago.

There are solar panels at the property and it is assumed that these are solely owned with the subjects. It would be prudent to establish if there is any associated documentation.

It is assumed that the road adjacent to the property is adopted by the local authority. The adjoining footpath is unsurfaced and there may be a responsibility for associated maintenance. Details should be verified.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

1.3 Liability

The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. 



The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 61 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 22 tonnes of carbon dioxide every year. About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

3 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

4 Condensing boiler

A condensing boiler is capable of much higher efficiencies than other types of boiler, meaning it will burn less fuel to heat this property. This improvement is most appropriate when the existing central heating boiler needs repair or replacement, however there may be exceptional circumstances making this impractical. Condensing boilers need a drain for the condensate which limits their location; remember this when considering remodelling the room containing the existing boiler even if the latter is to be retained for the time being (for example a kitchen makeover). Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

5 Double glazed windows

Double glazing is the term given to a system where two panes of glass are made up into a sealed unit. Replacing existing single-glazed windows with double-glazed windows will improve comfort in the home by reducing draughts and cold spots near windows. Double-glazed windows may also reduce noise, improve security and combat problems with condensation. Building regulations apply to this work and planning permission may also be required, so it is best to check with your local authority on what standards need to be met. A building warrant is not required if the windows comply with the current requirements.

6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Low and zero carbon energy sources
